

## ESTA ORDER FORM

### Important Information

An ESTA is only required for those who do not hold a visitor's visa for the USA and are eligible to travel on the VWP. The Visa Waiver Program is not open to all nationalities. Please carefully check your nationality's requirements. An ESTA approval is not a guarantee of entry into the United States, only an authorisation from the US Government that the traveller may board a carrier for travel to the US by air or sea under the rules of the VWP.

- An ESTA authorisation lasts for multiple entries over 2 years or the life of the passport, whichever is shorter.
- If passport details change, e.g. a passport is renewed or name changes, a new ESTA must be completed.
- The US Government fee £11. Regent Visas service fee £19 + VAT.

### ESTA Application—ALL questions MUST be answered

The wording of the questions is as provided by the US Department of Homeland Security

Please allow up to 1 week for the ESTA process to be authorised, though a response can be instant.

- If authorisation is returned as pending, it may take up to 72 hours for a decision to be made.
- If authorisation is refused, you will require a full visa for travel, for which Regent Visas cannot assist.
- If authorisation is granted, Regent Visas will send confirmation details by email or post as per your instructions.
